

Notification of important changes concerning voting rights under L. 3556/2007 [28.6.2017]

Alpha Bank A.E. (the “Bank”) announces, pursuant to the provisions of L. 3556/2007, that Blackrock, Inc., following a relevant notification on 27 June 2017, holds indirectly as of 26 June 2017 voting rights that correspond to an equal amount of common, registered, voting, dematerialised shares above the 5% threshold of the total voting rights of the Bank.
