### ΑΠΟΤΕΛΕΣΜΑΤΑ ΔΗΜΟΠΡΑΣΙΑΣ ΟΜΟΛΟΓΟΥ 1,75% ΛΗΞΗΣ 18 ΙΟΥΝΙΟΥ 2032

Σήμερα διενεργήθηκε επανέκδοση μέσω δημοπρασίας Ελληνικών τίτλων 1,75%, λήξεως 18 Ιουνίου 2032, ύψους 500 εκατομμυρίων Ευρώ. Η δημοπρασία πραγματοποιήθηκε μέσω των Βασικών Διαπραγματευτών Αγοράς (*Primary Dealers*). Οι συνολικές προσφορές ανήλθαν σε 1.934 εκατ. Ευρώ και η ημερομηνία διακανονισμού είναι η Δευτέρα 18 Ιουλίου 2022.
