## RE OPENING OF GGB 3.375 %, 15 JUNE 2034 AUCTION RESULTS

An auction of GGB 3.375%, 15 June 2034 was conducted today. Total bids reached EUR 835 million and the amount finally accepted was EUR 250 million. Settlement date is May 29, 2024. The results of the auction are as follows:
