Papoutsanis' vision is to create a flexible and reliable organization for those who use our products throughout the world.

FORTHCOMING PROJECTS/ INVESTMENTS – BUSINESS PLAN HIGHLIGHTS

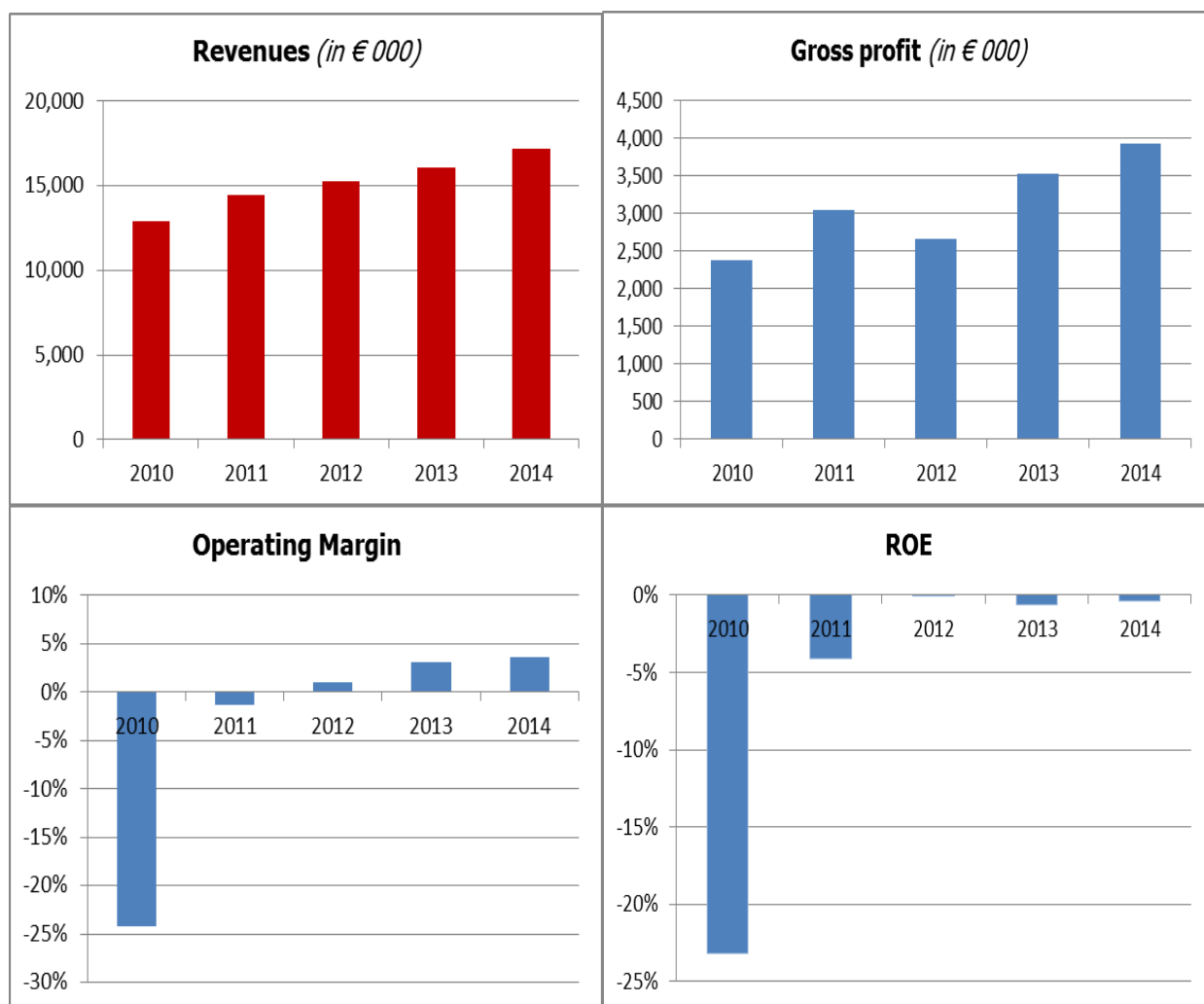
- At this stage the strategy is to continue expanding through organic growth in all three areas that company is active in branded products, hotel amenities and third party manufacturing.
