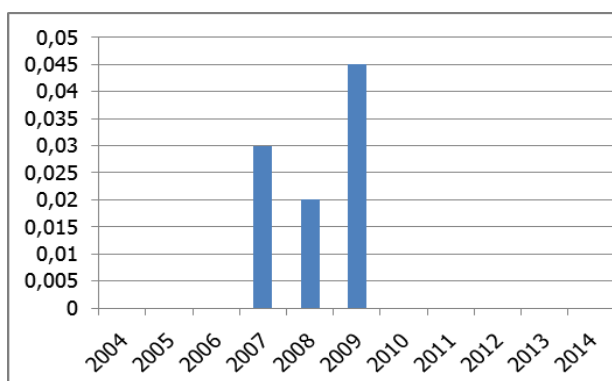
COMPANY PROFILE

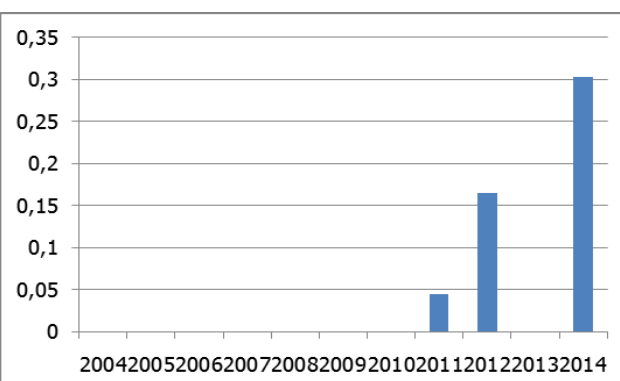

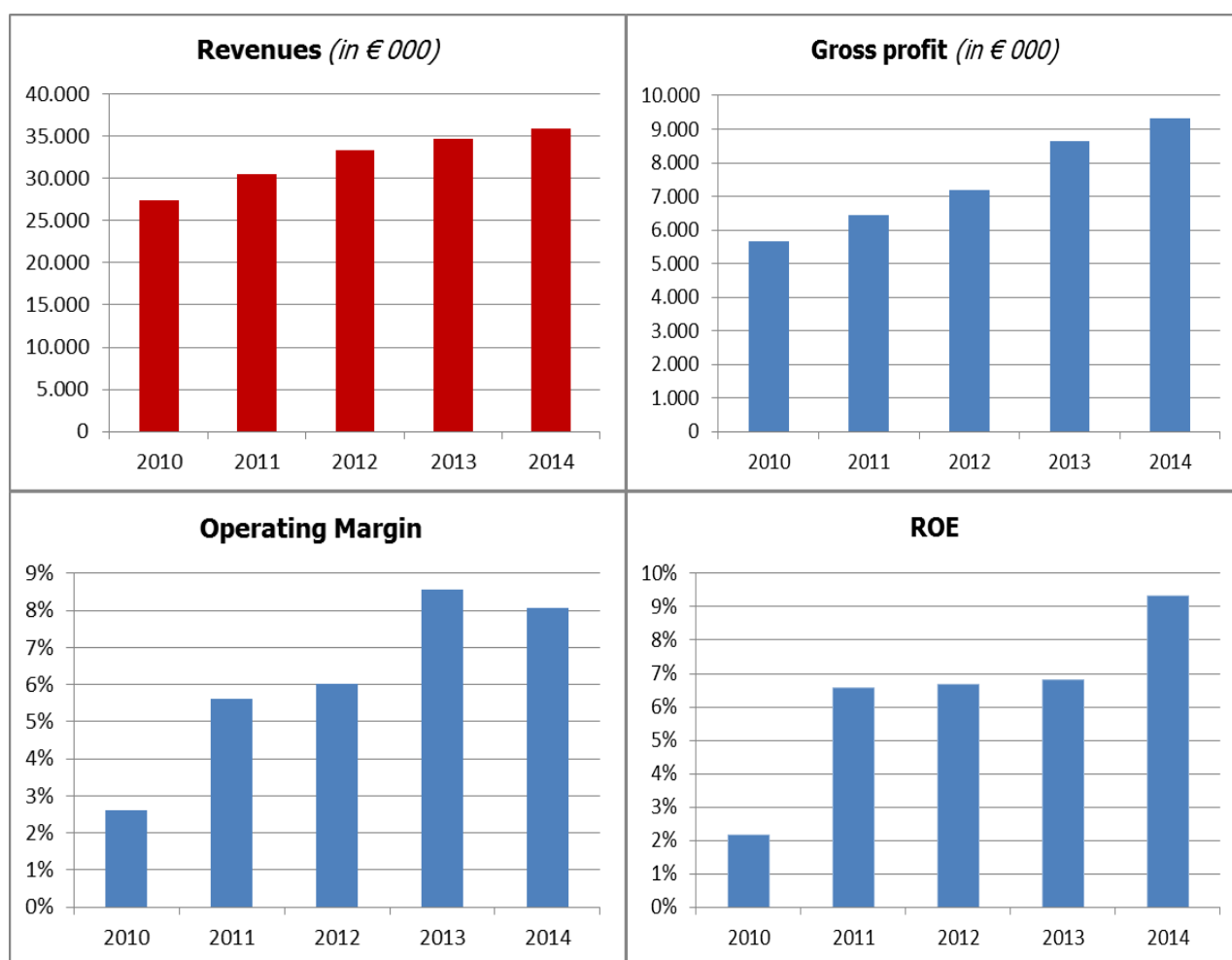


Capital Return (in €)
