COMPANY PROFILE

Leveraging on its deep know-how in the toys business, its extensive POS network (more than 1,800 points around Greece), and its robust licensing portfolio, AS Company has become one of the key players in the Southeast Europe Toy market.

AS Company is positioning itself exceptionally well in the toy market, holding approximately 12% share, 2nd largest share.

The company has also established a Logistics Centre, in order to support sales and better serve its customers. The privately owned building in Thessaloniki covers an area of 16,000 m².

AS success is based on a) being exclusive representative of globally known products with highly aware brands b) a dedicated marketing and R & D department c) long term relationships with toy & game retail chains, supermarkets and hypermarkets and d) healthy balance sheet that can support financing requirements of working capital and investments.

The strengthening of export sales in the toy sector comprises a key priority for the Company's future business growth.

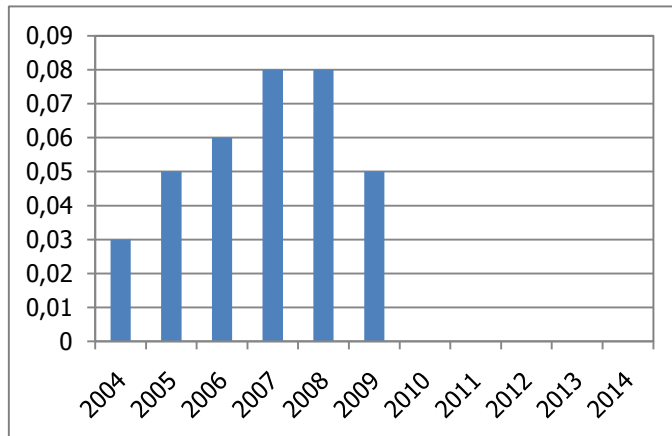
2015 Exports are estimated at €3M.

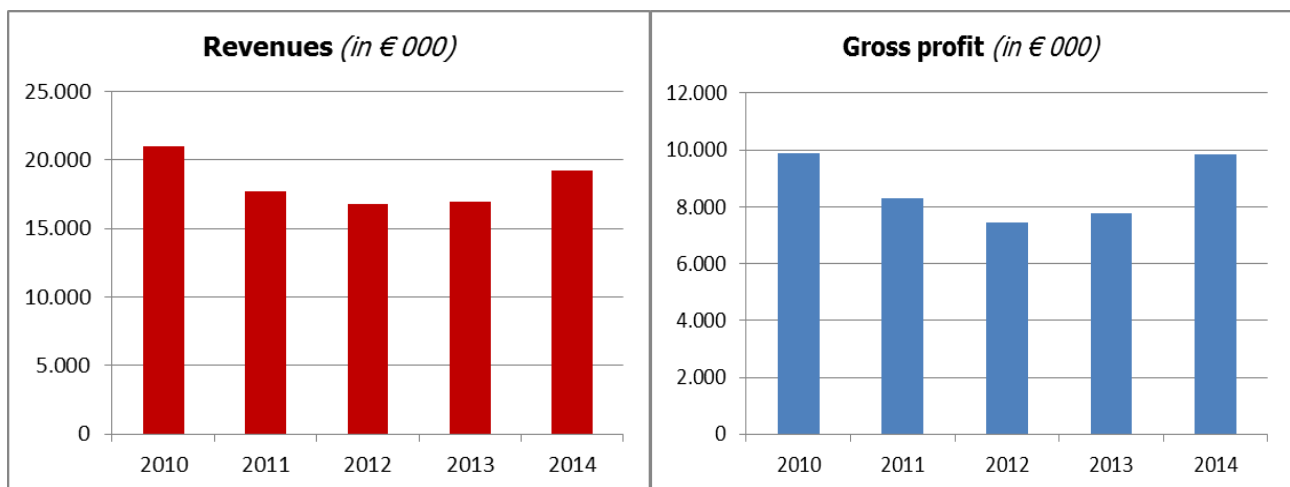

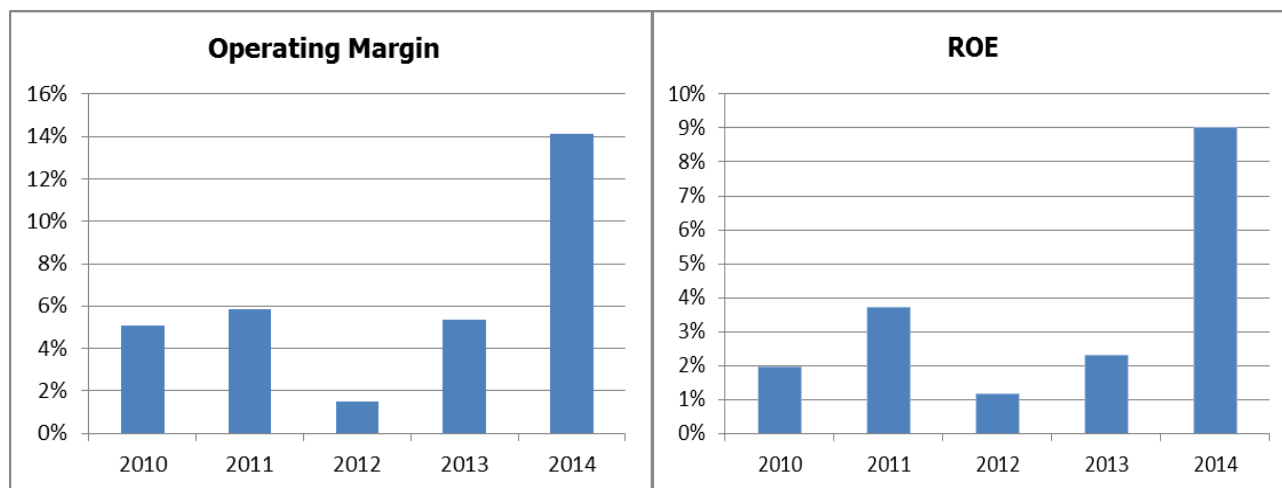
DIVIDEND POLICY-DPS (in €)
