COMPANY PROFILE

Jumbo SA is a Greece-based company that is engaged in the retail trade industry. The Company's main activity is the retail sale of toys, baby items, seasonal items, decoration items, books stationery and seasonal products. A small part of its activities is the wholesale of toys and similar items to third parties. The Company's network consists of a number of stores situated in Greece, Cyprus, Bulgaria and Romania. The Company's main subsidiaries are Jumbo Trading Ltd, which is headquartered in Cyprus and is active in the retail trade of toys; Jumbo EC.B LTD, which is based in Bulgaria, and Jumbo EC.R SRL, which is based in Romania. The Company's indirect subsidiaries are Aspetto Ltd based in Cyprus and Westlook SRL based in Romania. The Group also has approximately 270.000 sqm freehold modern warehouses.






DIVIDEND POLICY - DPS (in €)




Capital Return *(in €)*




