Announcement of EYATH Group's Financial Results

for the 6-month period ended 30 June 2019

The reinforced social profile of EYATH SA through the implementation of its new pricing

policy which has resulted in tariff reductions, increased provisions for insecurities due to the

application of a new International Accounting Standard and increased energy costs due to the

increase in the price of carbon emissions from 13 euros to 25 euros ton, are reflected in the

financial results of the first half of 2019.

Particularly

① Consolidated turnover amounted to € 35.622 compared to € 39.396 in the respective

period last year, recording a decrease of € 3,774 or 9,58%.

♠ Profit before tax amounted to € 10.036 compared to € 14.989 in the respective period last

year, showing a decrease of € 4.953 or 33,05%.

⚠ After tax profits amounted to \in 6.622 compared to \in 10.829 in 30/6/2018, a decrease of \in

4.207 or 38,85%.

⚠ EBITDA earnings amounted to € 12.634 compared to € 17.206 in the respective period

last year, indicating a decrease of 26,57%.

↑ The company has a strong cash basis of € 82.72 million, increased by 15,47% compared

to 31.12.2018

① The share capital remains unchanged at € 40,656 million divided into 36,300,000 shares

with a nominal value of € 1.12 each.

1 The Equity of the Group amounted to \in 175.19 million at 30.06.2019.
