### ANNOUNCEMENT OF DISPOSAL OF OWN SHARES

**Brussels, 16 December 2019, 14:00 CET - Titan Cement International SA** (Euronext Brussels, ATHEX and Euronext Paris, TITC) announces, in accordance with article 8:6 of the Royal Decree of 30 April 2019 implementing the Belgian Companies and Associations Code, the disposal by its subsidiary, Titan Cement Company S.A. ("Titan S.A."), of 25,255 shares in Titan Cement International S.A. ("TCI").

The TCI shares were sold on 11 December 2019 by Titan S.A. to five employees of the Titan Group through OTC transactions in the context of the exercise of stock options at an exercise price of € 10 per share, for a total amount of € 252,550.

Following the above transactions, Titan S.A. owns 4,804,140 TCI shares, representing 5.83% of the voting rights of TCI.
