

Share buy-back announcement

FOURLIS HOLDINGS S.A. announces in accordance with article 49 of Law 4548/2018, pursuant to the decision of the Ordinary General Meeting of the Shareholders dated 14.06.2019 and the decision of the Board of Directors dated 13.01.2020, that on 24/03/2020 purchased 12.500 own shares, at an average price of €3,3618 per share, a total value of €42.022,51.

Following the aforementioned purchase, the Company currently holds 91.220 treasury shares or 0,1754% of the total number of issued shares of the Company.
