



Latest Financial Results

At Group level, for 2019, **turnover** reached € 15.8 million compared to € 13.8 million in 2018, increased by 14%, as a result of new projects awarded as well as customer loyalty in the company's solutions.

EBITDA amounted to € 4.3 million compared to € 4.1 million in 2018, while the EBITDA Margin remained at satisfactory levels of 27.6%, as a result of the higher contribution to revenue of own product sales.

In 2019, **Earnings Before Taxes** amounted to € 2.4 million compared to € 1.7 million, thus showing a significant increase of 43%.

Earnings after Taxes and minority interests reached € 1.8 million from € 1.3 in 2018, increased by 40%.




