

## Announcement of disposal of own shares

**Brussels, 2 August 2021, 17:30 CEST** – Titan Cement International S.A. (Euronext Brussels, ATHEX and Euronext Paris, TITC) announces, in accordance with article 8:6 of the Royal Decree of 30 April 2019 implementing the Belgian Companies and Associations Code, the disposal by its subsidiary, Titan Cement Company S.A. (“Titan S.A.”), of 590 shares of Titan Cement International S.A. (“TCI”), to two (2) executive Titan Group employees, in the context of existing stock option plans.

The above TCI shares were sold on 30 July 2021 by Titan S.A., through OTC transactions, at an exercise price of €10 per share (i.e. € 5,900 in total).

Following the above transactions, Titan S.A. owns 985,705 TCI shares, representing 1,26% of the voting rights of TCI.
