

Notice of Dividend Payment for the year 2022

The Societe Anonyme under the name "AS COMMERCIAL- INDUSTRIAL COMPUTER AND TOY COMPANY SA" and the distinctive title "AS COMPANY S.A." with Commercial Registry Number 057546304000 (hereinafter "Company") notifies the investing public, in accordance with paragraphs 4.1.3.4 and 5.2 of the Athens Stock Exchange Regulations, as in force, that the Ordinary General Meeting of the Shareholders of the Company that took place on 23.06.2023 decided to distribute a gross dividend for the year 2022 amounting to 0,1157894737 euro per share, increased by the dividend corresponding to the 62.440 own shares held by the company that are not entitled to a dividend.

Please note that, according to the current tax provisions (article 64 of law 4172/2013, as amended and in force), the dividend to be distributed is subject to withholding tax of 5% (with the exception or variation of the withholding rate for Shareholders who are subject to special provisions). As a result, the net amount to be paid to the Shareholders shall amount to 0,1105257671 euro per share.

On Wednesday, June 26th, 2023, the shares will be traded without the right to the above dividend (dividend entitlement cut-off day). Beneficiaries of this dividend are the Shareholders of the Company registered in the files of the Intangible Securities System (ISS) managed by the "Hellenic Central Securities Depository Societe Anonyme" on Thursday, June 27th, 2023 (Record Date).

The payment of the dividend will be conducted on Tuesday, 1st of August 2023 by "Piraeus Bank S.A.", as follows:

- 1. Through the participants of the beneficiaries in the ISS (Banks and Stock Exchanges), in accordance with the regulations in force of EL.K.AT.
- 2. Especially in cases of dividend payment to heirs of deceased beneficiaries, whose titles are kept in the Special Account of their Shareholding tab in the ISS, under the management of ATHEXCSD, the dividend payment procedure will be carried out after the completion of the legitimacy of heirs, through the network of the bank "Piraeus Bank S.A.".

Any dividends that will not be collected within 5 years from 2023, ie until 31-12-2028, are written-off in favour of the Greek State (article 250 c. 15 and 253 of the Greek Civil Code) and will be attributed definitively to the Greek State, according to article 1 of Decree 1195/1942.

After Wednesday, 01.01.2025 and onwards, the dividend will be paid only at the Company's headquarters at Oreokastro, Thessaloniki (Ionias Str.).
