**Strategic Partnership between Fournalis Group and Latsco Family Office, for the participation of Latsco Hellenic Holdings Sarl in the share capital of Trade Estates REIC**

**Fournalis Group** and **Latsco Family Office** hereby announce their agreement for the participation of **Latsco Hellenic Holdings Sarl** in the share capital of **Trade Estates REIC**. More specifically, Latsco Hellenic Holdings Sarl acquires the 4.2% of Trade Estates REIC share capital, from TRADE LOGISTICS S.A., a Fournalis Group subsidiary, for a cash consideration of €8,000,000.

Fournalis Group holds 83.9% of the remaining Trade Estates REIC share capital and Autohellas of Vassilakis Group holds 11.9%.

It is reminded that Trade Estates REIC Initial Public Offering and its listing in the Athens Stock Exchange is expected to take place within the next month.

**Mr. Vasileios Fournalis**, Executive Chairman of Fournalis Holdings S.A., stated: *“We are very excited about the participation of Latsco Hellenic Holdings Sarl in Trade Estates REIC. This participation is of strategic importance both in view of Latsco Family Office extensive experience in the Greek and international real estate market and in light of Trade Estates Initial Public Offering and its listing in the Athens Stock Exchange market. Latsco Family Office decision to co-invest with us in Trade Estates is a strong validation of the quality of our properties and the strategic direction of the company”.*
