Public Power Corporation S.A. ("PPC") announces that in the context of its buy-back programme for the purchase of up to 38,200,000 of its own shares, for the period from 05.12.2024 until 12.12.2024, PPC purchased through transactions in the Athens Exchange, 472,575 Own Shares in total, as follows:

It is noted that, on 13.12.2024 the Company proceeded to the cancellation of 12,730,000 own shares with a corresponding decrease of its share capital by € 31,570,400 which resulted to the share capital amounting to € 915,789,600 divided to 369,270,000 common registered shares.

Following the above-mentioned purchases, PPC holds an aggregate of 18,716,084 shares issued by it, which correspond to 5.0684% of the Company's total shares.
