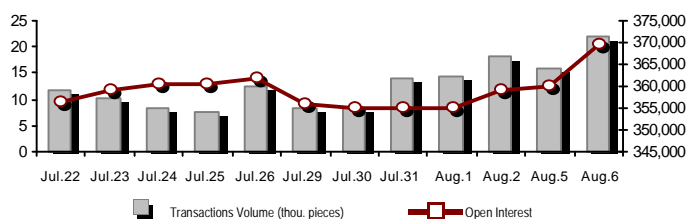

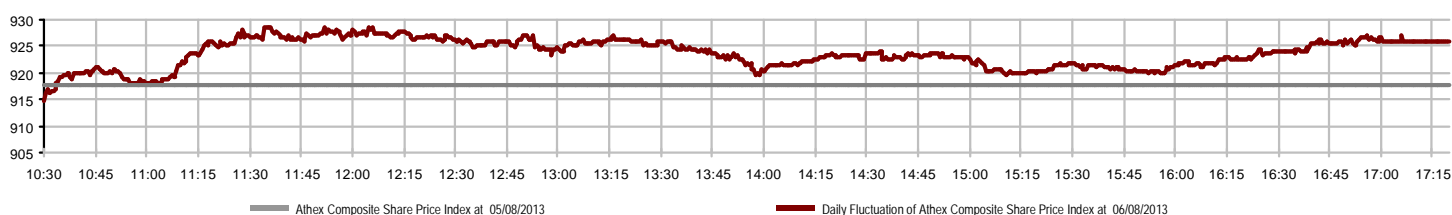
Athex Capitalisation (mill. €)**

Daily Fluctuation of Athex Composite Share Price Index



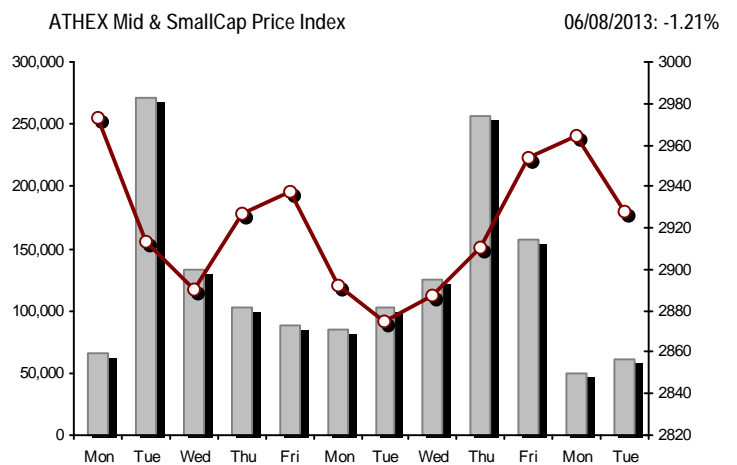
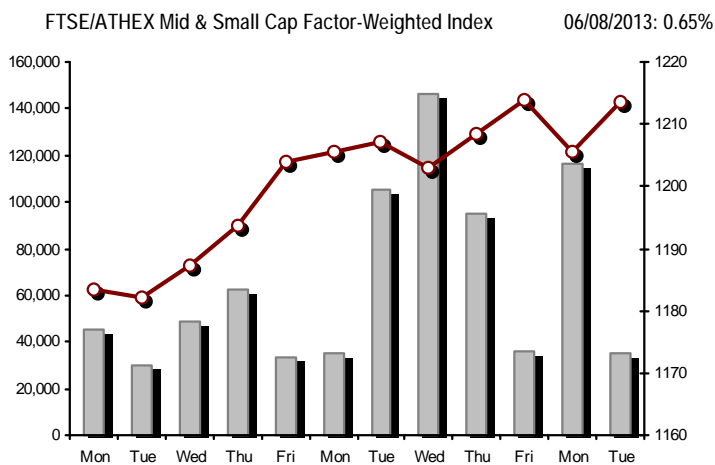
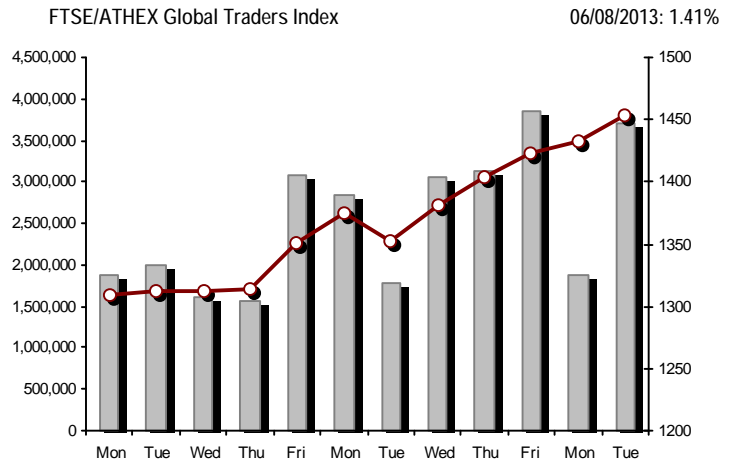
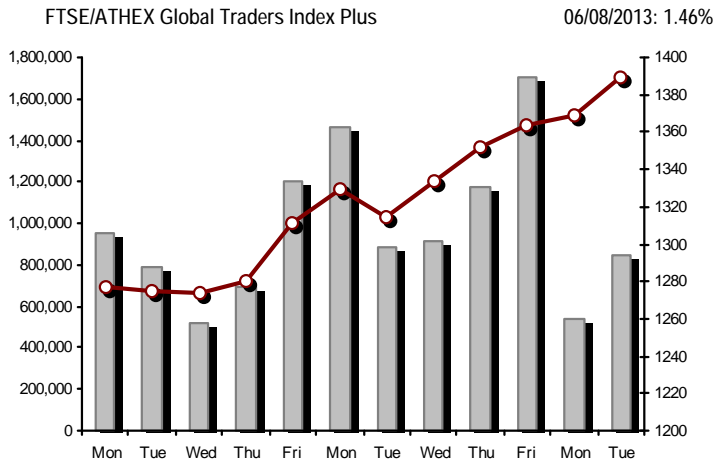
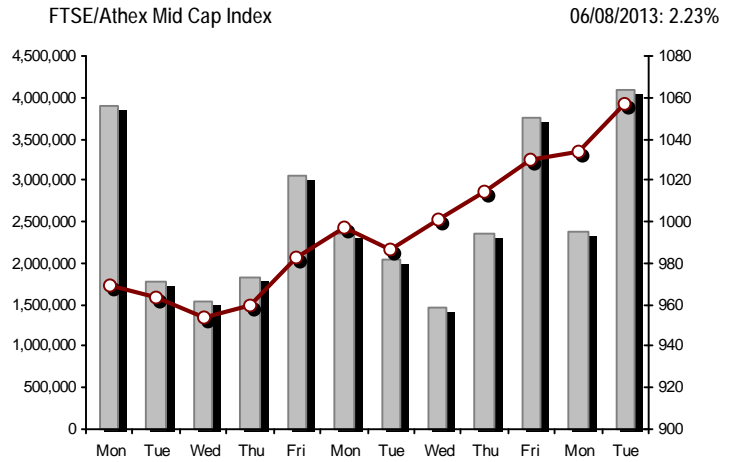
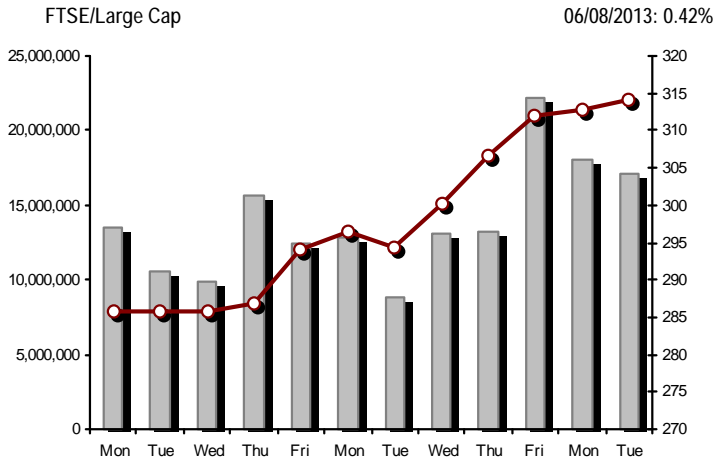
