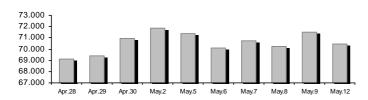

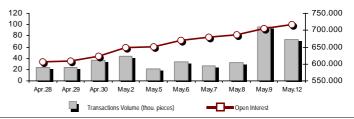

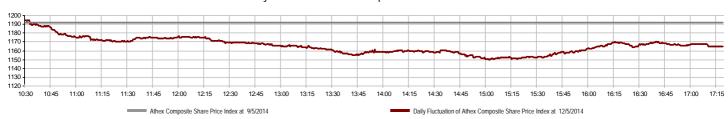

Daily Fluctuation of Athex Composite Share Price Index



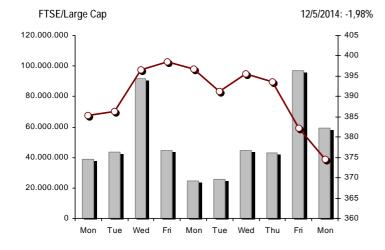

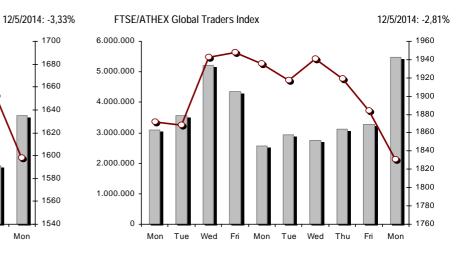


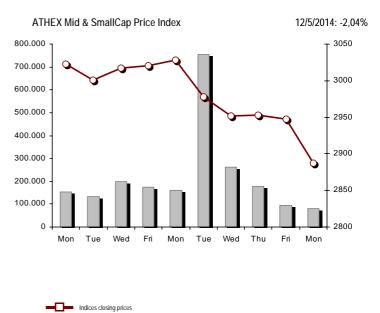
FTSE/ATHEX Mid & Small Cap Factor-Weighted Index
