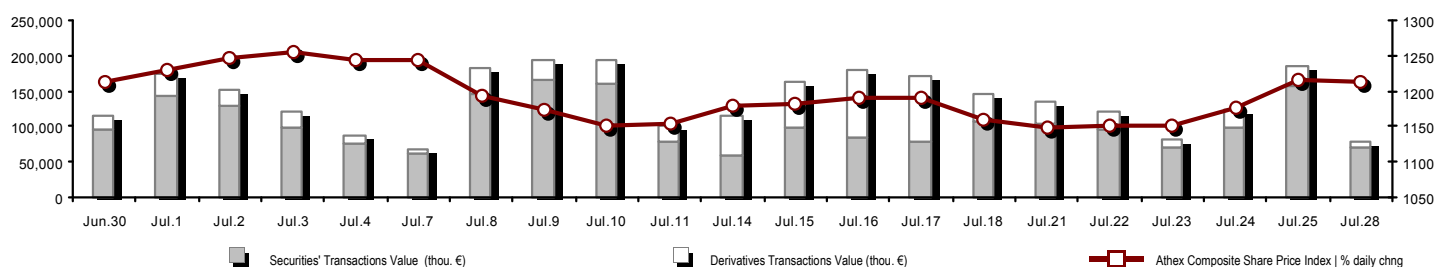

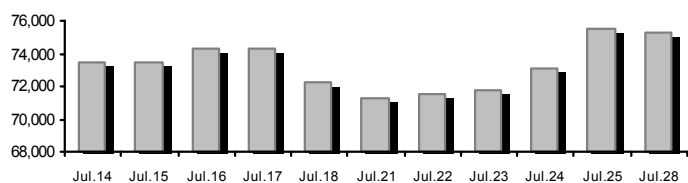

Athex Composite Share Price Index vs Shares and Derivatives Transactions Value

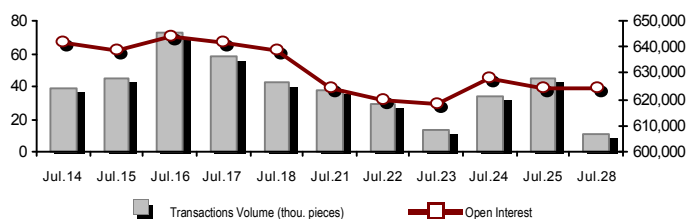

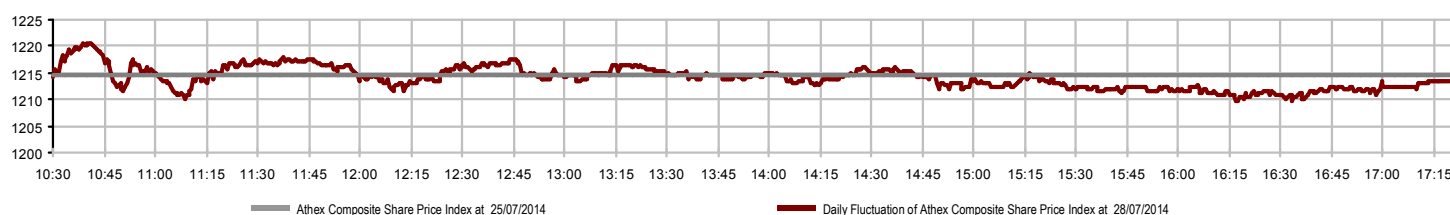
Athex Capitalisation (mill. €) **

Daily Fluctuation of Athex Composite Share Price Index



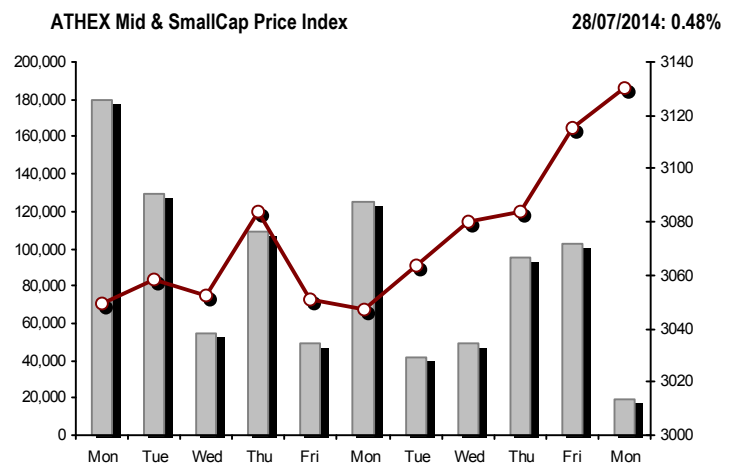
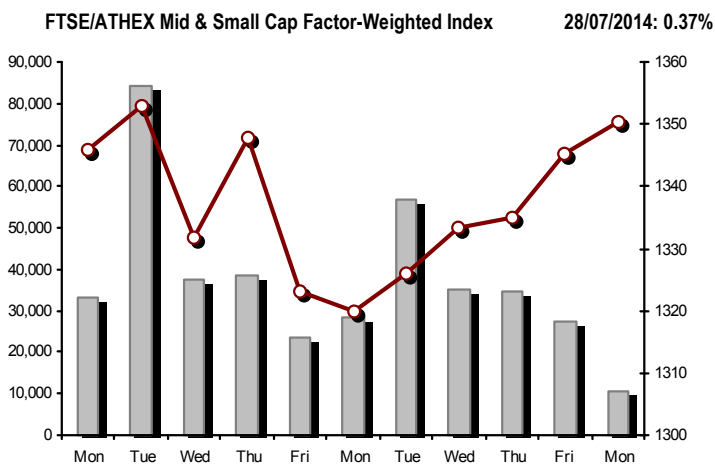
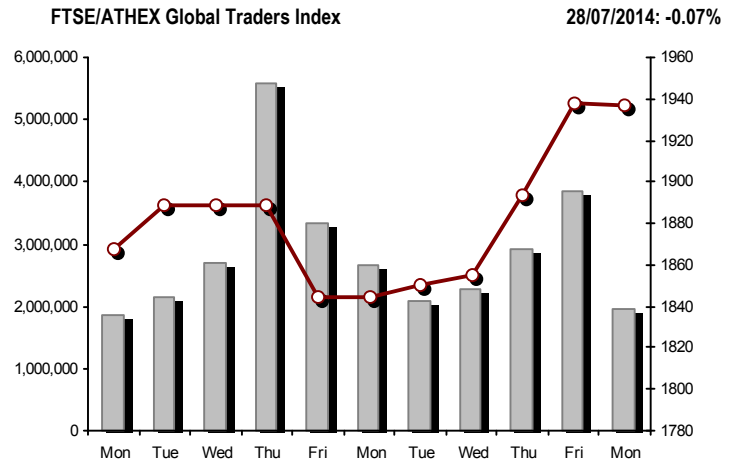
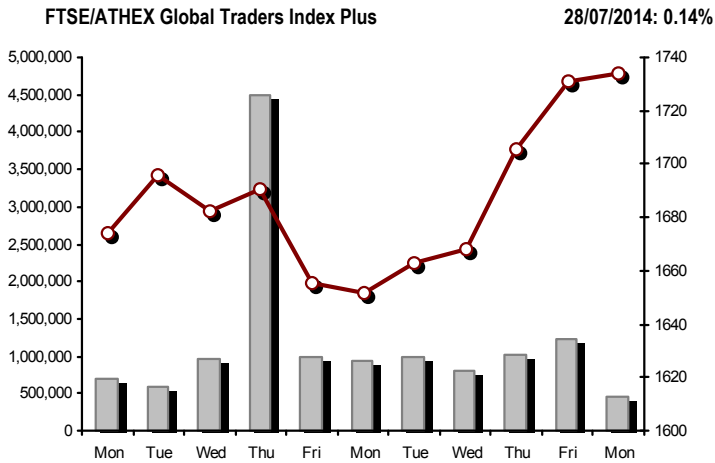
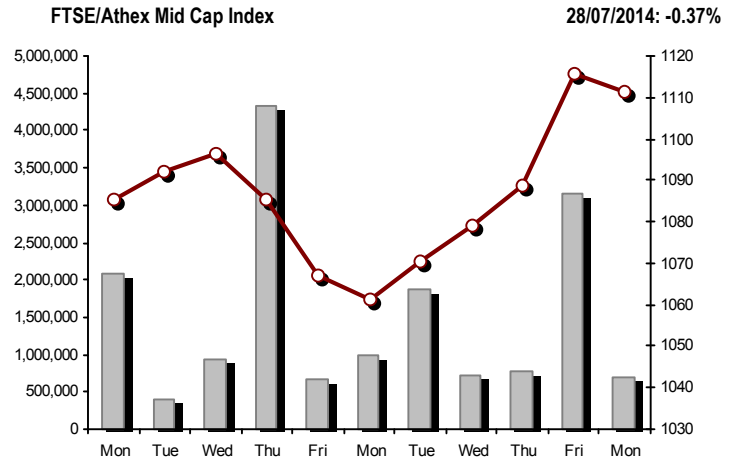
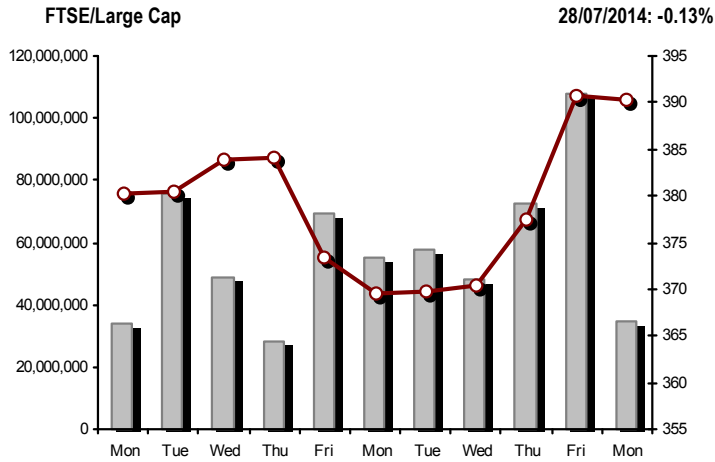
