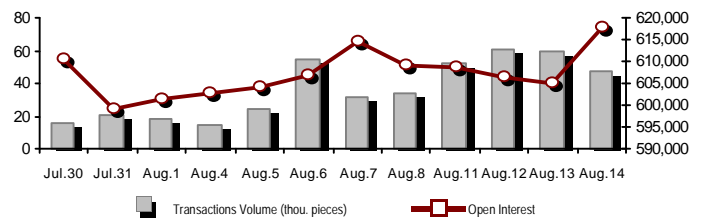

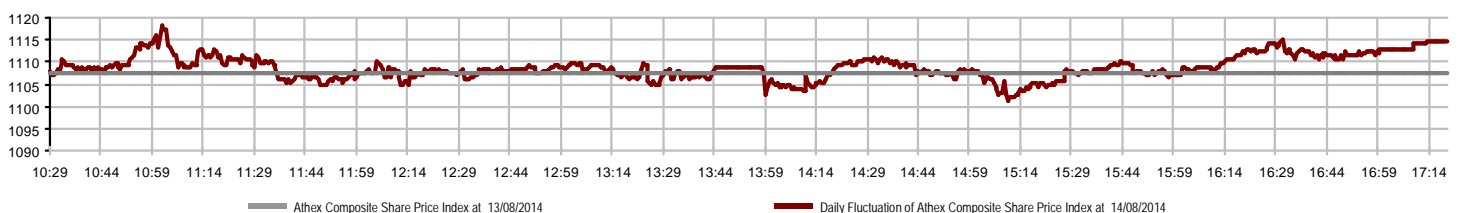
Athex Capitalisation (mill. €) **

Daily Fluctuation of Athex Composite Share Price Index



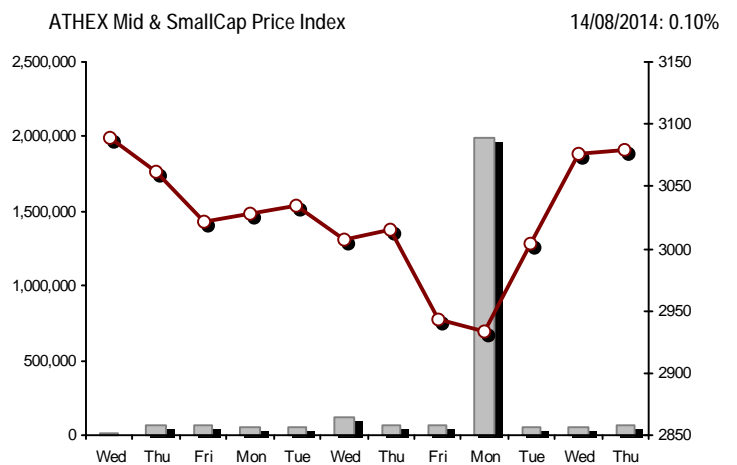
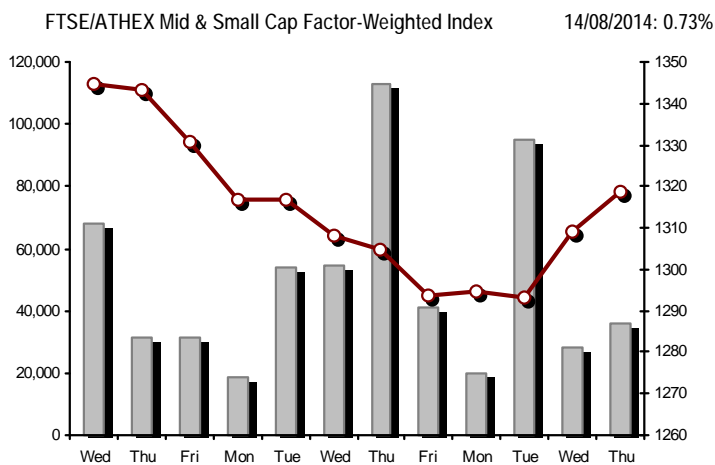
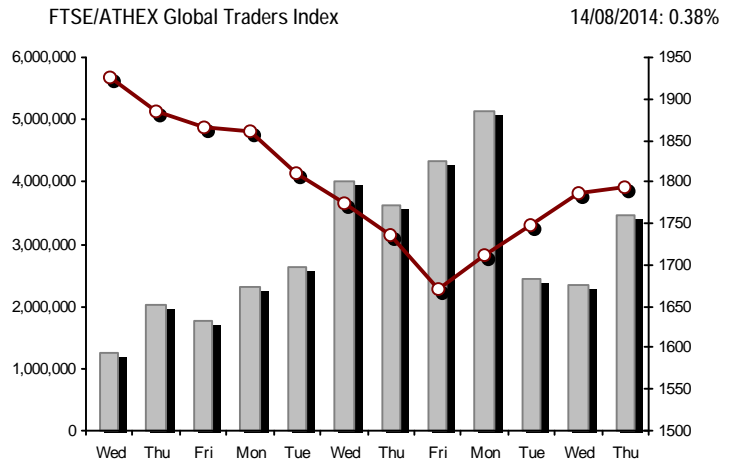
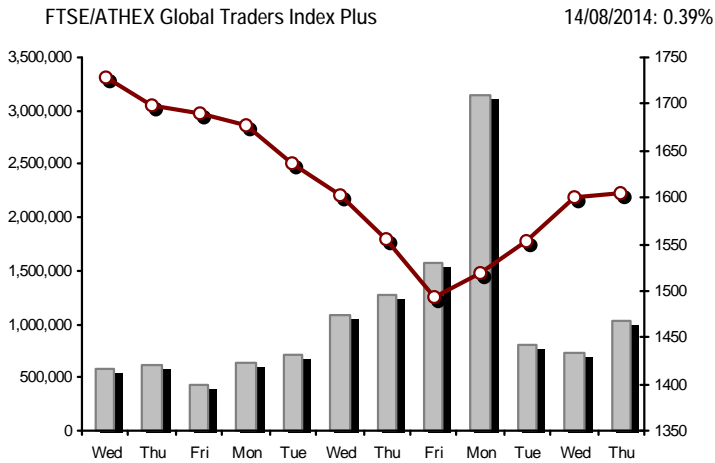
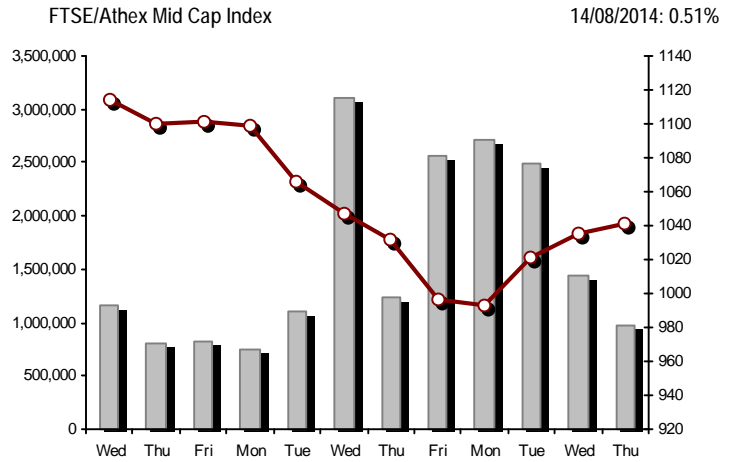
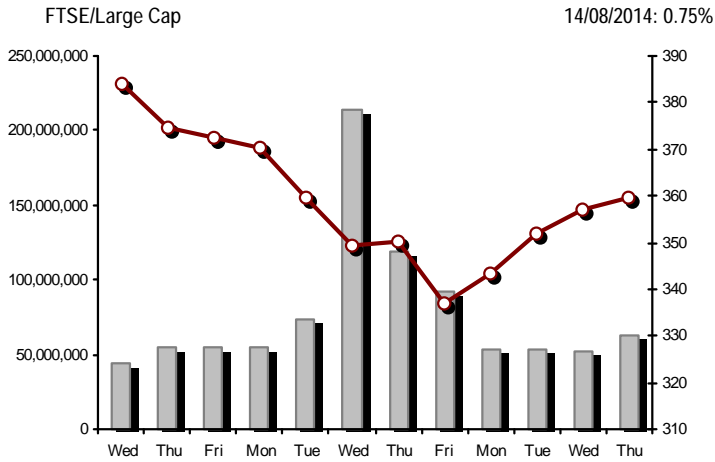
