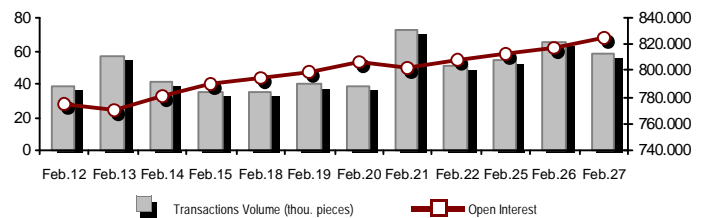

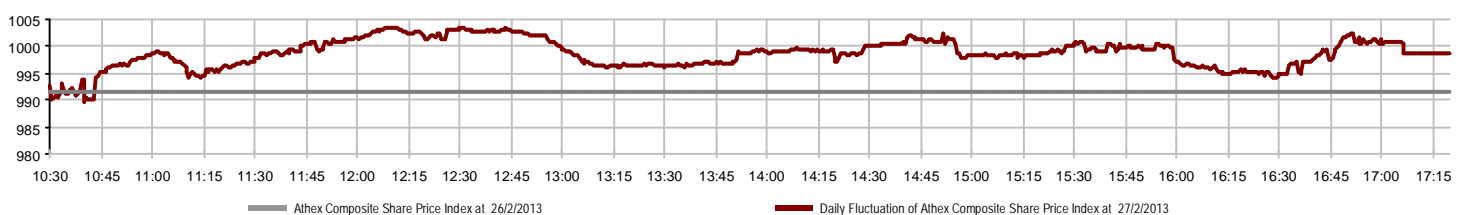
Athex Capitalisation (mill. €)

Daily Fluctuation of Athex Composite Share Price Index



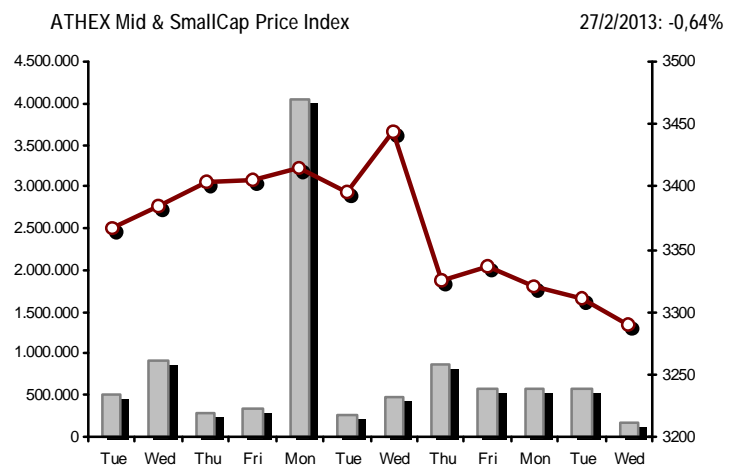
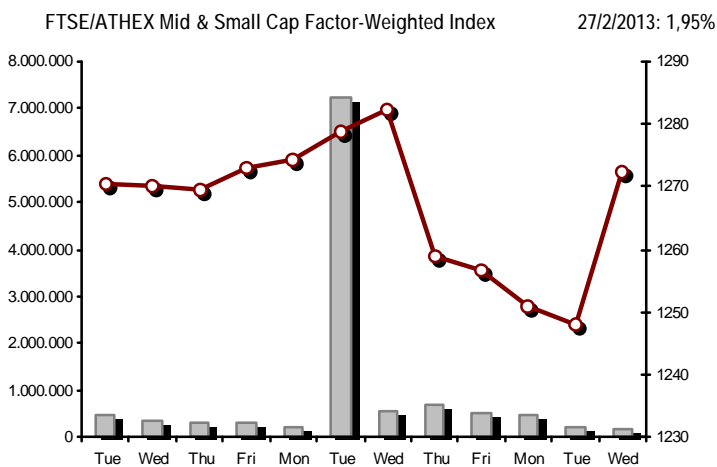
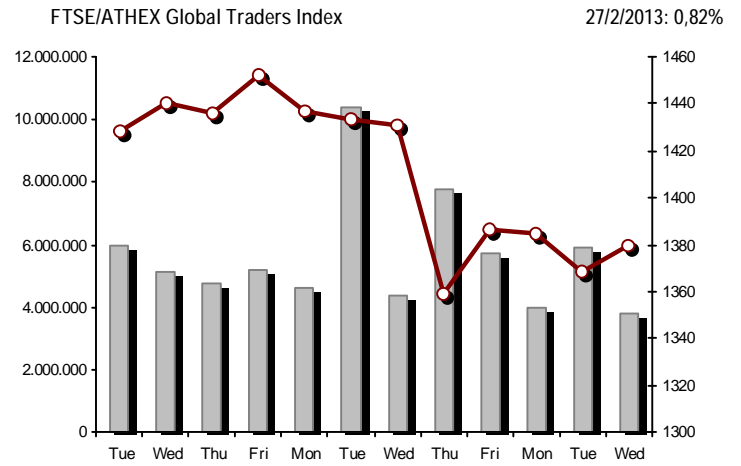
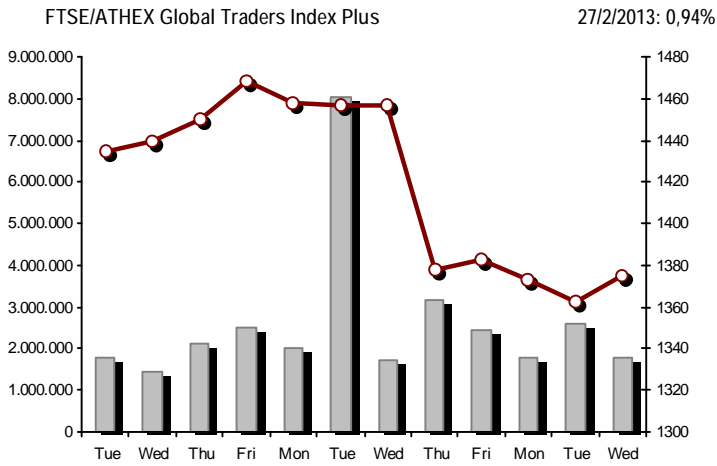
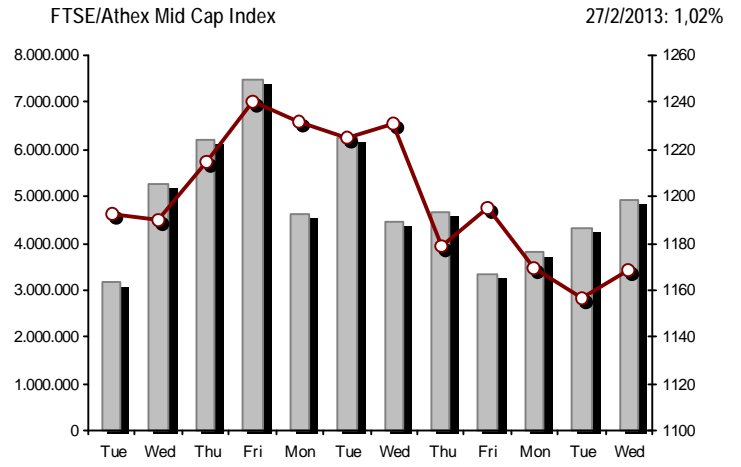
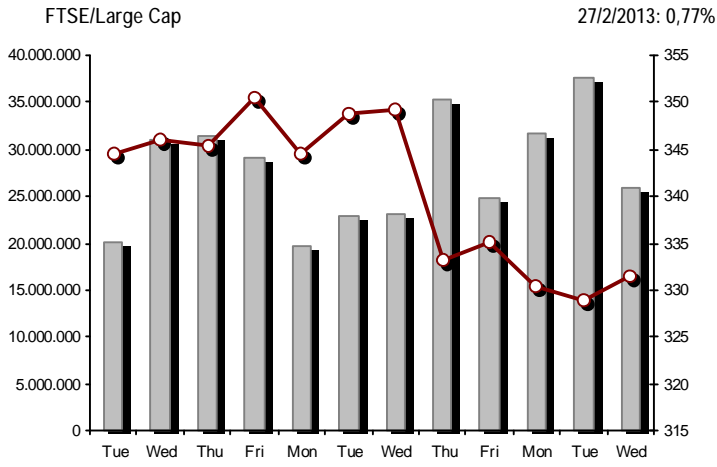
