Public Power Corporation S.A. ("PPC") announces that in the context of its buy-back programme for the purchase of up to 38,200,000 of its own shares, for the period from 20.02.2025 until 26.02.2025, PPC purchased through transactions in the Athens Exchange, 279,934 Own Shares in total, as follows:

Following the above-mentioned purchases, PPC holds an aggregate of 21,427,472 shares issued by it, which correspond to 5.8027% of the Company's total shares.

It is noted that, on 13.12.2024, PPC proceeded to the cancellation of 12,730,000 own shares resulting in its share capital amounting to 369,270,000 common registered shares. This share capital decrease does not change the abovementioned maximum number of shares (38,200,000) that PPC may purchase. Therefore, on 12.02.2025, the total number of shares issued by PPC that it may purchase until the termination of the current buy-back programme amounts to 4,042,528.
